A RESOLUTION AUTHORIZING PARTICIPATION IN

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Vineland, that the City of Vineland is authorized to participate as a Member of the Cumberland County Commodity Resale System (No. 99025-CCCRS) for purchase of gasoline, diesel fuel, snow removal chemicals, including salt brine, and public works materials; and that the Mayor is hereby authorized to execute a contract and related documents as required.



RESOLUTION NO. 2012 - 89

A RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT WITH THE COUNTY OF CUMBERLAND FOR THE PURCHASE OF SALT BRINE PURSUANT TO THE COMMODITY RESALE PROVISIONS OF THE COOPERATIVE PURCHASING RULES.

WHEREAS, N.J.S.A. 40A:65-4, (Shared Services Act), permits any local unit of the State to enter into an agreement with any other local unit or units for the joint provision within their several jurisdictions of any service which any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, the County of Cumberland owns and operates a salt brine storage and dispensing facility; and


WHEREAS, the City of Vineland is desirous of making use of the County's salt brine system; and

WHEREAS, the County has agreed to provide to the City salt brine at a cost of \$0.25 per gallon; now, therefore,

BE IT RESOLVED by the City Council of the City of Vineland that pursuant to the provisions of N.J.S.A. 40A:65-4 (Shared Services Act), the Mayor is hereby authorized to execute a Shared Services Agreement between the City of Vineland and the County of Cumberland for the purchase of salt brine pursuant to the Commodity Resale Provisions of the Cooperative Pricing rules.

BE IT FURTHER RESOLVED that the Agreement shall be in effect until April 8, 2016 upon approval by the governing bodies of the County of Cumberland and the City of Vineland.


