

ORDINANCE NO. 2014- 14

AN ORDINANCE AMENDING ORDINANCE 2013-65 AUTHORIZING IMPROVEMENTS FOR THE MUNICIPAL WATER UTILITY AND APPROPRIATING \$91,000.00 FOR THE WATER-SEWER UTILITY CAPITAL IMPROVEMENT FUND BY INCREASING THE APPROPRIATION BY \$49,130.30.

WHEREAS, on December 23, 2013, the City Council of the City of Vineland, adopted Ordinance No. 2013-65, entitled “An Ordinance Authorizing Improvements for the Municipal Water Utility, and Appropriating \$91,000.00 Therefor from the Water-Sewer Utility Capital Improvement Fund for the Financing Thereof”; and

WHEREAS, the purpose of the ordinance is to purchase an emergency portable generator to be used at any water treatment plant as needed in case of emergency power failure and a large portable water pump that can handle substantial water flows from a water main break in emergency situation or even by-pass pumping needs; and

WHEREAS, the portable water pump has been purchased leaving a balance of \$61,000.00

WHEREAS, the cost of the portable generator to be purchased is \$110,130.30 which is substantially higher than the original portable generator proposed, requiring an additional \$49,130.30; and

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vineland that Ordinance No. 2013-65, be amended to provide for additional funding in the amount of \$49,130.30 for the purchase of an emergency portable generator.

Respectfully request permission to amend ordinance 2013-65 from \$91,000.00 to \$139,500.00. This ordinance was for the purchase of a portable water pump and portable generator. The pump was purchased and the ordinance balance is \$61,000.00. The original price for the portable generator from HD Supply under the state contract has risen because the company who was supplying the generator to HD Supply was purchased by another company in 2014. I was originally buying a Baldor generator. Baldor was bought by a company named Generac, and the price on a comparable generator rose to \$110,130.30 needing a difference of \$48,500.00. We are still in need of this portable power supply requiring an amendment to the original ordinance. This will be funded by the Water Utility Capital Improvement Fund.
