# A RESOLUTION AUTHORIZING AN EXTENSION OF SUB-GRANTEE AGREEMENTS FOR 2013 VINELAND MUNICIPAL ALLIANCE PROGRAM ACTIVITIES.

WHEREAS, the City of Vineland has received funding from a Cumberland County Alcoholism and Drug Abuse Services Grant - Vineland Municipal Alliance for the period January 1, 2013 to December 31, 2013; and

WHEREAS, the Governor's Council on Alcoholism and Drug Abuse has extended the 2013 grant term until June 30, 2014, in order to transition the grant to a fiscal year rather than calendar year cycle; and

WHEREAS, said grant program provides for certain activities to be implemented by the Southwest Council Inc.; Vineland Police Athletic League; Vineland Public Schools; Sacred Heart High School; South Jersey Youth Alliance; Rescue Community Program; Visions of Hope; Boys and Girls Club of Vineland; DH / Perfil Latino TV, Inc.; Vineland Health Department – Red Ribbon Week Campaign & Alliance Advertising; and Coordinator of Alliance Activities; and

WHEREAS, said funds are available in the Reserve for Cumberland County Alcoholism and Drug Abuse Services Grant - Vineland Municipal Alliance - 2013, and have been certified by the City Comptroller;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that the Mayor and City Clerk are hereby authorized and directed to execute agreements with the above sub-grantees, extending the grant program period from January 1, 2014 to June 30, 2014 for activities to be implemented under the Cumberland County Alcoholism and Drug Abuse Services Grant - Vineland Municipal Alliance.

All publications, announcements, brochures, press releases, promotional items etc. that are designed by grantee using these funds must say Supported by funds from the Vineland Municipal Alliance and the GCADA through the Vineland Department of Health.

Information regarding meetings (selecting a representative and attending a minimum of 7 meetings annually) that was previously in the contracts can stay the same.
