# A RESOLUTION AUTHORIZING AN AGREEMENT FOR PROFESSIONAL SERVICES WITH TTI ENVIRONMENTAL, INC., MOORESTOWN, NJ, FOR REMEDIAL INVESTIGATION OF PROPERTY KNOWN AS BLOCK 7110, LOT 1, LOCATED AT 141 SHERIDAN AVENUE.

WHEREAS, TTI Environmental, Inc., Moorestown, New Jersey, has been prequalified to provide as needed Environmental Consulting Services to the City of Vineland, pursuant to Resolution No. 2013-104; and

WHEREAS, TTI Environmental, Inc., Moorestown, New Jersey, has completed a Preliminary Assessment and Site Investigation for property proposed for acquisition by the City located at 141 Sheridan Avenue, Vineland, New Jersey; and

WHEREAS, the next phase is the remedial investigation; and

WHEREAS, TTI Environmental, Inc. has submitted a proposal for Remedial Investigation of the subject property, in the amount of \$8,023.58; and

WHEREAS, the Director of Economic Development has recommended that a contract for the required services be awarded to TTI Environmental, Inc., based upon the proposal received, pursuant to a fair and open process; and

WHEREAS, the availability of funds for said Professional Services Contract to be awarded herein have been certified by the City Comptroller; and

WHEREAS, the Local Public Contract Law (N.J.S.A. 40A:11-1, et seq) requires that the Resolution authorizing the award of contract for Professional Services without competitive bidding and the contract itself must be available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that said contract for Professional Services for Remedial Investigation of property known as Block 7110, Lot 1, located at 141 Sheridan Avenue, Vineland, New Jersey, be awarded to TTI Environmental, Inc., Moorestown, New Jersey, based upon the proposal received, pursuant to a fair and open process, in an amount not to exceed \$8,023.58, for a contract period not to exceed one year from Notice to Proceed.



TTI Environmental, Inc. (TTI) is pleased to provide you with this Remedial Investigation (RI) proposal. For your ease of review, the proposal is organized in the following manner:

### 1.0 BACKGROUND

TTI performed a Preliminary Assessment Report (PAR) at the subject property. The PAR identified six (6) AOCs which required further action. In order to evaluate is these AOCs have impacted the site, TTI returned to the site on April 4, 2014 to conduct a Site Investigation (SI). The SI was conducted in compliance with NJAC 7:26E Technical Requirements for Site Remediation. The following two (2) AOCs yielded data above the applicable NJDEP criteria and will require delineation:

AOC 2A

Soil sample SB-2, collected in a drum storage area directly in front of the building, returned a result of 0.22 mg/kg for Benzo(a)pyrene and the standard is 0.20 mg/kg.

### AOC 2B

Soil sample SB-10, collected in a drum storage area away north of the asphalt area in front of the building, returned an Extractable Petroleum Hydrocarbon (EPH) result of 24,000 mg/kg, which is above the 17,000 mg remediation threshold.

### 2.0 SCOPE OF WORK

#### **Remedial Investigation**

Using a hand auger; TTI shall advance the soil borings at the specific areas of concern to determine the horizontal and vertical extent of affected media. Each boring shall be field-screened using a calibrated Photoionization Detector (PID), as well as visual and olfactory assessments by experienced field technician personnel.

#### AOC 2A

TTI shall collect five (5) soil samples for analysis of benzo(a)pyrene.

#### AOC 2B

TTI shall collect five (5) soil samples for EPH Category II analysis.

All laboratory data will be assessed to current New Jersey Department of Environmental Protection (NJDEP) criteria. All laboratory analysis shall be performed on a normal turnaround time of one (1) week. TTI shall prepare a report summarizing the findings with recommendations for further action.

## 4.0 GENERAL TERMS AND CONDITIONS

Warranty

TTI warrants that its services are performed in accordance with the standards for professional services at the time those services are rendered. TTI warrants that it is familiar with the State, Federal and local laws and regulations governing the services to be provided under this contract and further warrants that it will comply fully with all such laws and regulations, including obtaining any required permits or making any required filings, in the performance of the work covered by this contract. TTI agrees to notify **City of Vineland** immediately of any occurrence or condition associated with its performance of services that might require notification to regulatory authorities. Except as provided herein, no other warranty or representation, either express or implied is included or intended in its proposals, contracts, reports.

#### Liability

TTI's pollution/professional liability shall not exceed \$5,000,000 for total allowable losses.

TTI's liability for bodily injury and property damage shall not exceed \$5,000,000 per occurrence/\$5,000,000 aggregate.

TTI's automobile liability for bodily injury/property damage shall not exceed \$5,000,000 per occurrence.

#### Payment Terms – Invoicing

Invoices will be issued at the completion of work, delivery of materials and/or the end of each month, payable net ten (10) days from the date of the invoice.
