A RESOLUTION AUTHORIZING A PROFESSIONAL SERVICES CONTRACT WITH DR. DONATO TERRIGNO, BRIDGETON, NJ, TO BE MEDICAL DIRECTOR OF THE EMS DIVISION OF THE DEPARTMENT OF HEALTH.

WHEREAS, there exists a need for professional services for Medical Director of the EMS Division of the Department of Health; and

WHEREAS, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that the resolution authorizing the award of a professional services contract without competitive bidding and the contract itself must be available for public inspection.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that:

- 1. The Mayor and City Clerk are hereby authorized and directed to execute a contract with Dr. Donato Terrigno, Bridgeton, NJ to be Medical Director of the EMS Division of the Department of Health from January 1, 2014 through December 31, 2014 in an amount not to exceed \$6,600.00.
- 2. This contract is awarded without competitive bidding as a "professional service" in accordance with N.J.S.A. 40A:11-5(1)(a) of the Local Public Contracts Law because said services to be rendered or performed require knowledge of an advanced type in a field of learning acquired by a prolonged formal course of specialized instruction and study as distinguished from general academic instruction or apprenticeship and training.
- 3. That the Business Disclosure Entity Certification and the Political Contribution Disclosure Form be placed on file with the Resolution.
- 4. A notice of this action shall be printed once in the Daily Journal.
