

RESOLUTION NO. 2014- 239

A RESOLUTION AUTHORIZING THE SALE AND REMOVAL OF SCRAP ALUMINUM WIRE, SCRAP STREET LIGHTS, AND MIXED METALS FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY – DISTRIBUTION DIVISION.

WHEREAS, pursuant to N.J.S.A. 40A:11-36, any contracting unit by resolution of its governing body may authorize the sale of its personal property not needed for public use; and

WHEREAS, the City of Vineland advertised for quotations for the Sale and Removal of Scrap Aluminum Wire, Scrap Street Lights, and Mixed Metals for the Vineland Municipal Electric Utility – Distribution Division; and

WHEREAS, on May 28, 2014, quotations were received by the Purchasing Board and reviewed by Management Personnel of the Municipal Electric Utility; and

WHEREAS, it is recommended that it is in the best interest of the City of Vineland to accept the highest quotes received, as follows:

Landis Building Service & Recycling LLC, Vineland, NJ

Item 1 – Scrap Copper Wire (includes insulation) - \$2.230 per pound

Groundbreaker on Ebay, Vineland, NJ

Item 2 – Scrap Aluminum Wire (includes insulation) - \$0.352 per pound

Item 3 – Aluminum Street Light Housings, includes ballasts and Refractor (lamps removed) - \$0.181 per pound

Giordano's Recycling, Vineland, NJ

Item 4 – Mixed Metals - \$8.000 per pound

NOW, THEREFORE, BE IT RESOLVED by this City Council as follows:

1. THAT the Scrap Aluminum Wire, Scrap Street Lights, and Mixed Metals for the Vineland Municipal Electric Utility – Distribution Division, as indicated above, is no longer needed for public use.
2. THAT Buyers agrees to:
 - Provide certified weight of empty vehicle they will be using to remove the scrap. Certified weight slips must show vehicle tag number and description of the scrap clearly indicated on weigh slip. Buyer to have scrap weighed at a local certified scale, (not their own) accompanied by a city employee. All costs associated with weighing, will be paid by buyer. Payment to the City will be on the actual weight (lbs) of the scrap, verified by the weight slips, at the price submitted per lb.
 - All scrap shall be removed within ten (10) business days of notification of award. The City must be given 24-hour notice prior to removal.
 - Loading and removal is the sole responsibility of the buyer. The City of Vineland will be available to aid in the loading of the scrap.
 - Payment: Cash or check (check payable to the City of Vineland)
3. THAT the Mayor and City Clerk are authorized to execute an Agreement of Sale for the above-referenced sale.

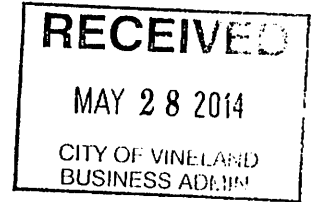
