A RESOLUTION AWARDDING AN OPEN-END CONTRACT FOR THE FURNISHING OF SOLID AND LIQUID WASTE DISPOSAL FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY - GENERATION DIVISION, TO CLEAN VENTURE INC., ELIZABETH, NJ.

WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing of Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility – Generation Division, for a period of one year beginning July 1, 2014, with option for a second year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on May 28, 2014, a bid was received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of June 17, 2014 submitted a written report and tabulation of the bid received and has recommended that an open-end contract for the furnishing of Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility – Generation Division, for a period of one year beginning July 1, 2014, with option for a second year, be awarded to Clean Venture, Inc., Elizabeth, NJ, in the amount of \$164,795.00, said bid being the only bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-end contract for the furnishing of Solid and Liquid Waste Disposal for the Vineland Municipal Electric Utility – Generation Division, for a period of one year beginning July 1, 2014, with option for a second year, be and the same is awarded to Clean Venture Inc., Elizabeth, NJ, in the amount of \$164,795.00, said bid being the only bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.

Submitted to you herewith for your consideration is our evaluation of the proposals submitted to the Purchasing Board on May 8, and May 28, 2014.



Contract for Solid and Liquid Waste Disposal Services

On April 22, 2014 a request for proposals was issued for solid and liquid waste disposal services at the electric utility. The deadline for receipt of proposals was May 28, 2014. A proposal from Clean Venture Inc. was the only response to the request. VMEU's existing contract for solid and liquid waste disposal is with Clean Venture and expires on June 30, 2014. Clean Venture's proposal is for one year beginning July 1, 2014 with an option for a second year.

The specification requests unit prices for solid and liquid waste disposal, labor rates, and equipment rental rates. The expected total annual cost for waste disposal is determined based on the estimated anticipated quantities of various solid and liquid wastes and proposed unit prices. Total estimated annual cost based on Clean Venture's unit prices is \$164,795. Please be advised that this estimate includes the removal of an estimated 50 cubic yards of fly ash in the Unit 7 and Unit 10 silos plus 10 tons of fly ash located in the settling basin. Unlike the other sources of solid waste the quantity of fly ash is limited because coal is no longer burned at the power plant. Based on Clean Venture's unit prices the cost for removal of the fly ash from the silos and the settling basin is \$66,120. Excluding the removal of fly ash, total annual cost for solid and liquid waste disposal is \$98,675 which is very close to our estimate and budget of \$100,000. The total amount of the contract award, \$164,795, will be spread over 24 months extending into 2015. It is anticipated that removal of the fly ash will be deferred until fiscal 2015.

Based on proposed unit prices, compliance with the specification, and past performance an award to Clean Venture is recommended.
