- 3. THAT the Lead Agency shall be responsible for complying with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) and all other provisions of the revised statutes of the State of New Jersey.
- 4. THAT this resolution shall take effect immediately upon passage.

There is no fee to join and members are lifetime members with no need to renew this membership. The Commissions' State of New Jersey approved Coop number is 65MCESCCPS. All MRESC co -op member applications are approved by the New Jersey State Department of Community Affairs.

The MRESC Co-op conducts Vendor Fairs periodically in order to provide our members and vendors an avenue in which to become familiar with one another.
