A RESOLUTION AWARDDING A CONTRACT TO RUMSEY ELECTRIC CO., CONSHOHOCKEN, PA FOR THE FURNISHING AND DELIVERY OF WEST CT CABLE REPLACEMENT 15 KV URD CABLE.

WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing and delivery of West CT Cable Replacement 15KV URD Cable, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on January 29, 2015, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of February 3, 2015 submitted a written report and tabulation of the bids received and has recommended that a contract for the furnishing and delivery of West CT Cable Replacement 15KV URD Cable, be awarded to Rumsey Electric Co., Conshohocken, PA, in the amount of \$22,936.50, plus a 5% contingency in the amount of \$1,146.83, to allow for cable put-up tolerances, for a total amount of \$24,083.33, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the furnishing and delivery of West CT Cable Replacement 15KV URD Cable, be and the same is awarded to Rumsey Electric Co., Conshohocken, PA, on their bid in the amount of \$22,936.50, plus a 5% contingency in the amount of \$1,146.83, to allow for cable put-up tolerances, for a total amount of \$24,083.33, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.

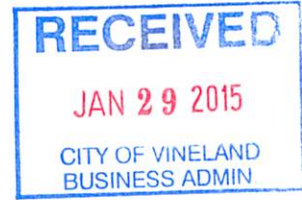
We trust that the above recommendations will receive your favorable consideration and that the recommended resolutions will be adopted as presented.

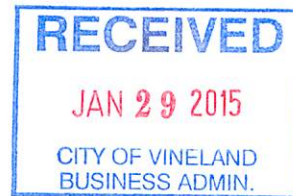
