

RESOLUTION NO. 2015- 105

A RESOLUTION AMENDING RESOLUTION 2015-80, DECLARING THE EXISTENCE OF AN EMERGENCY RELATED TO THE REMOVAL AND REPLACEMENT OF A STORMWATER PIPE ON DANTE AVENUE BETWEEN LINCOLN AVENUE AND JUNIOR DRIVE.

WHEREAS, the City Council of the City of Vineland on February 10, 2015, adopted Resolution No. 2015-80, entitled "A RESOLUTION DECLARING THE EXISTENCE OF AN EMERGENCY REQUIRING REMOVAL AND REPLACEMENT OF A DETERIORATING STORMWATER PIPE ON DANTE AVENUE BETWEEN LINCOLN AVENUE AND JUNIOR DRIVE, AND AUTHORIZING THE PAYMENT OF BILLS FOR SAID SERVICES"; and

WHEREAS, the City Engineer requested authorization in an amount not to exceed \$150,000.00 for the above services; and

WHEREAS, the City Engineer has now received quotes, the lowest being from South State Inc., Bridgeton, NJ, in an amount of \$176,355.00; and

WHEREAS, the City Engineer is requesting an amendment to Resolution No. 2015-80 to provide for an additional \$26,355.00 needed for the Dante Avenue Emergency Drainage Replacement; and

WHEREAS, the City Comptroller has certified the availability of funds for the above emergency;

NOW, THEREFORE BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF VINELAND:

1. THAT Resolution No. 2015-80 is hereby amended to provide the additional \$26,355.00 needed to complete the Dante Avenue Emergency Drainage Replacement between Lincoln Avenue and Junior Drive.
2. THAT the City Engineer is hereby authorized and directed to contract with South State Inc., Bridgeton, NJ, for the Dante Avenue Emergency Drainage Replacement between Lincoln Avenue and Junior Drive.
3. THAT the Purchasing Agent is hereby authorized and directed to issue an amended purchase order to South State Inc., Bridgeton, NJ, for the additional \$26,355.00 for a total not to exceed \$176,355.00.
4. THAT payment is hereby authorized pursuant to said purchase order in accordance with procedures for payment of bills and demands heretofore established by Ordinance No. 1048.

WHEREAS, the City Engineer has reported that the condition of the 54" corrugated aluminum stormwater pipe on Dante Avenue between Lincoln Avenue and Junior Drive has rapidly deteriorated to one of imminent hazard to the public welfare and is considered an emergency condition; and

WHEREAS, authorization is requested to contract for the emergency removal and replacement of the deteriorating stormwater pipe on Dante Avenue between Lincoln Avenue and Junior Drive in an amount not to exceed \$150,000.00; and

WHEREAS, the City Comptroller has certified the availability of funds for the above emergency;

NOW, THEREFORE BE IT RESOLVED, BY THE COUNCIL OF THE CITY OF VINELAND:


1. THAT the City Engineer is hereby authorized and directed to contract for the emergency removal and replacement of the deteriorating stormwater pipe on Dante Avenue between Lincoln Avenue and Junior Drive.
2. THAT the Purchasing Agent is hereby authorized and directed to issue purchase order as authorized by the City Engineer for emergency removal and replacement of the deteriorating stormwater pipe on Dante Avenue between Lincoln Avenue and Junior Drive, in an amount not to exceed \$150,000.00.
3. THAT payment is hereby authorized pursuant to said purchase order in accordance with procedures for payment of bills and demands heretofore established by Ordinance No. 1048.


