THIS FIRST AMENDMENT TO THE COMMUNICATIONS ANTENNA SITE LEASE AGREEMENT ("First Amendment"), dated as of the latter of the signature dates below, is by and between THE CITY OF VINELAND, a municipal corporation of the State of New Jersey, having a mailing address of 640 East Wood Street, Vineland, New Jersey 08362-1508 ("City") and T-MOBILE NORTHEAST LLC, a Delaware limited liability company, having a mailing address of 12920 SE 38th Street Bellevue, WA 98006, successor in interest to Omnipoint Communications Enterprises L.P., a Delaware limited partnership ("Carrier").

WHEREAS, City and Carrier entered into a Lease Agreement dated June 17, 2002, whereby City leased to Carrier certain Premises, therein described, that are a portion of the Property located at 2245 Magnolia Road in the City of Vineland, New Jersey ("Agreement"); and

NOW THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, City and Carrier agree as follows:

- 1. Modification to the Facilities. Exhibit A to the Agreement is hereby amended to include the modifications identified on Exhibit A-1, a copy of which is attached and made a part hereof. Exhibit A-1 supplements Exhibit A to the Agreement, and shall not be deemed to supersede or otherwise modify Exhibit A or any part thereof except to the extent specifically set forth in Exhibit A-1. Upon full execution of this First Amendment, Carrier is permitted to do all work necessary to prepare, maintain and alter the Site to install or otherwise modify the Carrier's facilities, all as more fully described and contemplated in Exhibit A-1.
- 2. Limitations of Work; Inspection of Work. No changes other than those set forth on the designs shall be permitted as set forth in Exhibit A-1. The City shall be permitted to inspect all work to assure compliance with designs and all costs incurred by the City to assure compliance, including engineering and construction inspections shall be borne by the Carrier.
- 3. Modification to Basic Fee. As additional consideration for the modification and other rights set forth in this First Amendment, starting on the date that is thirty (30) days after the start of construction of the modifications to the Carrier's facilities, the Basic Fee will be increased by TWO HUNDRED and NO/DOLLARS (\$200.00) per month.


- (a). All capitalized terms used in this First Amendment, unless otherwise defined herein, will have the same meaning as the terms contained in the Agreement.

- (d). Each of the parties represents and warrants that it has the right, power, legal capacity and authority to enter into and perform its respective obligations under this First Amendment.


