We are requesting that an amendatory supplemental change order be issued for Contract No. C13-0109, issued to Cayenta, - a Division of N. Cayenta has been working with VMU staff on installing software, configuring systems and converting data for the new customer care and billing solution for the Vineland Municipal Utilities and solid waste services. We have gone live on the new Software on June 22nd. Cayenta and City staffs have been fixing issues relating to converted data quality and correcting system functional issues that are found. All in all the software is functioning well aside from the minor issues expected in a system conversion of this magnitude.

Project funding had been as needed until we pushed the go live date back one week and had to remobilize staffing. To allow the required delay post go live support was reduced to stay within authorized contract limits. I am requesting a final change order up to \$30,000.00 which is 2.2% of the original contract. The total change order dollars would be under the 20% threshold. Change order dollars will only be expensed for approve out of scope items that exceed the already authorized project dollars.

This software project is funded through a capital improvement authorization by Ordinance No. 2013-47 and all funding will remain within the authorized spending limits.
