WHEREAS, the City Comptroller has certified that funds for the amendment requested herein are available; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland as follows:

1. We are requesting an amendatory supplemental change order to Contract No. C12-0082, issued to Burns and Roe Enterprises, Inc., Oradell, NJ for Engineering Services to Install a Selective Catalytic Reduction (SCR) System on the Combustion Turbine at West Substation. This contract was authorized by Resolution No. 2013-480, adopted by City Council on December 11, 2012.

Reason for Change Order

Power Burns and Roe has provided engineering services for installation of the selective catalytic reduction (SCR) system on West Unit 1. The purpose of the SCR is to reduce nitrogen oxide emissions in order to comply with a regulation that went into effect this year. Construction is completed, and compliance with the new emission limits was successfully demonstrated during initial testing conducted on May 19, 2015.

Cumulative payments to Power Burns and Roe plus retention total \$1,038,354 to date. This amount is \$4,003.89 less than the original contract plus approved change orders. It is anticipated the cost of remaining services to be provided by Power Burns and Roe may exceed the remaining amount in the contract as estimated in the attached document from Power Burns and Roe.

TN Ward, the constructor for the SCR project, has recently submitted change order requests having questionable justification. Back charges will be submitted to Turner EnviroLogic, the supplier of the SCR, for costs incurred by VMEU that are the result of fabrication deficiencies. Participation of the project manager and a senior engineer from Power Burns and Roe in negotiating settlement on the change orders and back charges is very desirable. Although the amount of time they will devote to these tasks can only be estimated at this time, their participation of Power Burns and Roe in the negotiations is justified based on their familiarization with the project.
