WHEREAS, N.J.S.A. 52:34-6.2 permits the City of Vineland to purchase DC47 Digger Derrick using the offered National Cooperative Contract without public bidding, subject to the submittal and acceptance of certain documentation by Altec, Industries, Inc.;

WHEREAS, the City of Vineland intends under NJPA, under the Category: Public Utility Equipment with Related Accessories and Supplies, Contract #31014, to purchase from Altec Industries, Inc., 250 Laird Street, Plains, PA 18705, One (1) 2013 DC47 Digger Derrick, in an amount not to exceed \$195,548.00, as listed in the Quotation, dated May 26, 2015, made available through the NJPA.

WHEREAS, the availability of funds for said purchase to be awarded herein have been certified by the City Comptroller; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, that the Purchasing Agent is authorized to prepare a purchase order to procure the 2013 DC47 Digger Derrick, from Altec Industries, Inc. for a price not to exceed \$195,548.00

BE IT FURTHER RESOLVED that the purchase order shall contain a requirement that "the vendor shall maintain all documentation related to products, transactions or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request".
