**RESOLUTION AUTHORIZING TRANSFER OF EMERGENCY
 RESPONSE EQUIPMENT TO THE CITY OF VINELAND**

WHEREAS, through the Radiological Emergency Response Program, agencies can request equipment for their municipal departments; and

WHEREAS, in Fiscal Year 2010, the City of Vineland was approved to receive one (1) 2010 Homesteader Trailer (7' x 20'), Vehicle Identification #5HABE202XAN002483.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby authorizes transfer of one (1) 2010 Homesteader Trailer (7' x 20'), Vehicle Identification #5HABE202XAN002483 to the City of Vineland under the Radiological Emergency Response Program through the Cumberland County Office of Emergency Management.
2. That the cost of said trailer in the amount of \$5,607.00 shall be reimbursed by the State of New Jersey to the County of Cumberland.
3. That the Office of Emergency Management shall keep an accurate inventory of said equipment and provide the State Office Emergency Management with an inventory report upon reasonable request.
