A RESOLUTION AUTHORIZING A LETTER OF AGREEMENT BETWEEN THE CUMBERLAND-CAPE-ATLANTIC YMCA AND THE CITY OF VINELAND TO PROVIDE THE SERVICES REQUIRED TO SUPPORT THE NJ PARTNERSHIP FOR HEALTHY KIDS PROJECT.

WHEREAS, the Cumberland Cape Atlantic YMCA anticipates the continued grant funding from the Shaping NJ and the NJ State Health Department in connection with the NJ Partnership for Healthy Kids; and

WHEREAS, the Cumberland Cape Atlantic YMCA has agreed to award to the City of Vineland Department of Health, a total of \$2,680.00 beginning September 2015 through December 31, 2015 to provide technical assistance on the NJ Partnership for Healthy Kids Project, by mentoring and training the YMCA Staff to conduct a Healthy Kids Program, similar to Vineland's program, for the City of Atlantic City; and

WHEREAS, it is the desire of the Department of Health to accept the grant award and enter into an agreement with Cumberland Cape Atlantic YMCA;

NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Health Director or his designee are hereby authorized and directed to execute the Letter of Agreement and such other documents as required between Cumberland Cape Atlantic YMCA and the City of Vineland to provide services required to support the NJ Partnership for Healthy Kids Project.
