

ORDINANCE NO. 2015_____

AN ORDINANCE PROVIDING FOR NO PARKING RESTRICTIONS ALONG DEMARCO DRIVE AND INDUSTRIAL WAY.

WHEREAS, the City Engineer’s Office has recommended that parking be prohibited in a portion of the Industrial Park along the entire limits of DeMarco Drive and Industrial Way; and

WHEREAS, said recommendation has the concurrence of the Vineland Police Department and the City Solicitor and is considered to be in the best interest of the City of Vineland; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF VINELAND THAT:

SECTION 1. No person shall park a vehicle at any time upon any of the following described streets or parts of streets:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
DeMarco Drive	East	From the southerly curbline of Garden Road to northerly curbline of Industrial Way, a distance of 2,600 feet more or less
Industrial Way	Varies	Beginning at the intersection of the west edge of Mill Road and the southerly edge of Industrial Way; thence Along the southerly curb line of Industrial Way in a westerly direction, a distance of 2,000 feet; thence In a westerly direction along an arc, a distance of 450 feet; thence Along the westerly curb line of Industrial Way in a northerly direction, a distance of 900 feet; thence Along an arc in an easterly direction, a distance of 450 feet; thence Still along the northerly curb line of Industrial Way, in an easterly direction, a distance of 620 feet more or less to the westerly curb line of DeMarco Drive

SECTION 2. Signs shall be erected and maintained as authorized by the Commissioner of Transportation of the State of New Jersey.

SECTION 3. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This Ordinance shall take effect upon passage and publication as provided by law.

I have received concerns from business owners regarding the permissive parking in this portion of the industrial park. Please prepare an Ordinance establishing No Parking along the entire limits of DeMarco Drive and Industrial Way as follows:

DeMarco Drive	East	From the southerly curbline of Garden Road to the northerly curbline of Industrial Way, a distance of 2,600 feet more or less
Industrial Way	Varies	Beginning at the intersection of the west edge of Mill Road and the southerly edge of Industrial Way; thence Along the southerly curb line of Industrial Way in a westerly direction, a distance of 2,000 feet; thence In a westerly direction along an arc, a distance of 450 feet; thence Along the westerly curb line of Industrial Way in a northerly direction, a distance of 900 feet; thence Along an arc in an easterly direction, a distance of 450 feet; thence Still along the northerly curb line of Industrial Way, in an easterly direction, a distance of 620 feet more or less to the westerly curb line of DeMarco Drive
