A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO RICHARD E. PIERSON MATERIALS CORP., BRIDGEPORT, NJ FOR SUPPLYING AND DELIVERING VOC-COMPLIANT HIGH PERFORMANCE COLD PATCH THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Supplying and Delivering VOC-Complaint High Performance Cold Patch; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest, responsive, responsible bidder, Richard E. Pierson Materials Corp., Bridgeport, NJ, for the contract period September 1, 2015 through August 31, 2016 based on the quoted price as follows:

WHEREAS, the City of Vineland desires to enter into an agreement with Richard E. Pierson Materials Corp., for Supplying and Delivering VOC-Complaint High Performance Cold Patch under the cooperative pricing system contract awarded by the County of Cumberland for the contract period September 1, 2015 through August 31, 2016, in an amount based upon the quoted price, as stated above; and

WHEREAS, the City Comptroller has certified the availability of funds for the contract to be awarded herein;

1. THAT the Mayor and City Clerk are hereby authorized to execute an agreement with Richard E. Pierson Materials Corp., Bridgeport, NJ for Supplying and Delivering VOC-Complaint High Performance Cold Patch for the contract period September 1, 2015 through August 31, 2016, based upon the open-ended contract awarded by the County of Cumberland cooperative pricing system.
2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue a purchase order contract to Richard E. Pierson Materials Corp., for Supplying and Delivering VOC- Complaint High Performance Cold Patch, as stated above.

**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR  
 SUPPLYING AND DELIVERING VOC-COMPLIANT HIGH  
 PERFORMANCE COLD PATCH FOR THE CUMBERLAND COUNTY  
 PUBLIC WORKS DEPARTMENT AND THE CUMBERLAND COUNTY  
 COOPERATIVE CONTRACT PURCHASING SYSTEM IDENTIFIER  
 #181-CCCCPS; BID #15-48 (RICHARD E. PIERSON MATERIALS  
 CORP.)**

WHEREAS, this Board duly received and opened bids for supplying and delivering VOC-Compliant High Performance Cold Patch for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; and

WHEREAS, bids were received as follows:

\* For bid evaluation purposes \$4.00/mile was added for total round-trip mileage for County pick-up of materials from the bidders plant location; Richard E. Pierson Materials (4.68 miles x \$4.00 = \$18.72 x 50 round-trips = \$936.00 round-trip for County pick-up at Bridgeton Plant) plus supply/deliver equals \$126,936.00, South State (1.38 miles x \$4.00 = \$5.52 x 50 round-trips = \$276.00 round-trip for County pick-up at Bridgeton Plant) plus supply/deliver equals \$127,476.00 total bid, American Asphalt (71.62 miles x \$4.00 = \$286.40 x 50 round-trips = \$14,324.00 round-trip for County pick-up at Collingswood Plant) plus supply/deliver equals \$148,724.00 total bid and Garden State Highway Products (96.54 miles x \$4.00 = \$386.16 x 50 round-trips = \$19,308.00 round-trip for County pick-up at Elkton, MD Plant) plus supply/deliver equals \$182,808.00 total bid.

WHEREAS, the Director of Purchasing has reported that Richard E. Pierson Materials Corp., PO Box 704, Bridgeport, NJ 08014 was the lowest responsive, responsible bidder.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends an open-ended contract be awarded to Richard E. Pierson Materials Corp. in accordance with the specifications and the bid of the contractor in the amount of \$105.00/ton/600 tons for County pick up and \$105.00/ton for supply/deliver for the contract period September 1, 2015 through August 31, 2016 and said contract shall be contingent upon appropriation of sufficient funds in the temporary and/or permanent 2015 and 2016 Budgets.

2. That, additionally, Richard E. Pierson Materials Corp. shall be declared the winning bidder for the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS.

3. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.

4. That the proper account numbers will be charged and funds encumbered prior to services being provided.
