Good Afternoon!

Please put the acceptance of the above-noted grant on City Council agenda as soon as possible for us.

This grant is Year 3 for us. It requires me to be a mentor to 3 other Health Departments in the United States (One from N. Carolina, one from Wisconsin and one from northern NJ). I will have to call them once a month and they will come here for on-site training for 2 days in the spring. My training materials are already created from previous years and will take up no extra time to develop. For this effort on my part, we will receive \$16,000 towards furthering our retail food protection program. It will be spent as follows:

Overtime- (for inspections that must occur in the evenings or on the weekends and teaching of 1 food safety class in the evening)= \$4428

Supplies- (thermal imager, data logger, dishwasher thermometers and accessories for our laptops)= \$3,359
Printing and Postage- (for printing and mailing of 500 food safety calendars, created by our school children and for printing of other educational materials)= \$4,400

Training- (for various training/courses for the food inspectors to stay current with food safety knowledge or to increase their skills)= \$3,813
