WHEREAS, the Assistant Business Administrator has, under date of January 19, 2016 submitted a written report and tabulation of the bids received and has recommended that a contract for the Acquisition of One (1) 2016 AWD SUV Police Pursuit Vehicle, be awarded to Winner Ford, Cherry Hill, NJ, in the amount of \$52,366.00, said bid being the only bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the Acquisition of One (1) 2016 AWD SUV Police Pursuit Vehicle, be and the same is awarded to Winner Ford, Cherry Hill, NJ, on their bid in the amount of \$52,366.00, said bid being the only bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.

ACQUISITION OF ONE (1) 2016 AWD SUV POLICE PURSUIT VEHICLE

It is the recommendation of the Police Department which has the concurrence of the Purchasing Agent and Assistant Business Administrator that a contract be awarded to the only bidder, Winner Ford, Cherry Hill, NJ, in the amount of \$52,366.00.

FURNISHING AND DELIVERY OF ALUMINUM LINE WIRE & CABLE FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY – DISTRIBUTION DIVISION

It is the recommendation of the Director of Municipal Utilities, which has the concurrence of the Purchasing Agent and Assistant Business Administrator that a contract be awarded to the low bidder, Rumsey Electric Co., Conshohocken, PA, in the amount of \$91,441.24, plus a 5% contingency in the amount of \$4,572.06 (to allow for manufacturers standard length put-up tolerances of +/-10%), for the total amount of \$96,013.31.


