WHEREAS, on January 20, 2016, bids were received, duly opened and read aloud, being referred to the Assistant Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Assistant Business Administrator has, under date of February 2, 2016 submitted a written report and tabulation of the bids received and has recommended that a contract for the furnishing and delivery of a New Rear Loading 32 CY Compactor Truck for the Department of Public Works, be awarded to Hunter Jersey Peterbilt, Clarksburg, NJ, in the amount of \$238,500.00, said bid being the only bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the furnishing and delivery of a New Rear Loading 32 CY Compactor Truck for the Department of Public Works, be and the same is awarded to Hunter Jersey Peterbilt, Clarksburg, NJ, on their bid in the amount of \$238,500.00, said bid being the only bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

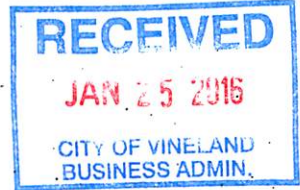
