WHEREAS, The Houston-Galveston Area Council National Cooperative Purchasing Program (HGAC-Buy) has acted as lead agency and awarded Contract #EF04-15, Law Enforcement Speed Detection & Video Equipment. WHEREAS, N.J.S.A. 52:34-6.2 permits the City of Vineland to purchase Mobile Video Recorders using the offered National Cooperative Contract without public bidding, subject to the submittal and acceptance of certain documentation by Safety Vision, LLC.

Such records shall be made available to the New Jersey Office of the State Comptroller upon request".
