ORDINANCE AMENDING THE CODE OF THE CITY OF VINELAND, CHAPTER 651, SECTION IV ENTITLED TAXICABS FEES

WHEREAS, it becomes necessary to calculate the cost associated with the issuance of renewals of taxicab license fees recognizing the time and effort put forth by the City; and

WHEREAS, the City Council finds it to be in the best interest of the taxpayers to increase the taxicab license fees.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vineland that City Code, Chapter 651 entitled Taxicabs, Section 5 entitled Fee shall be deleted in its entirety and replaced as follows:

- A. New Owners License Application Fee,  
For each taxicab per year:
  - (for year 2016): \$94.00
  - (for year 2017): \$97.00
  - (for year 2018): \$100.00
  - (for year 2019): \$103.00
  - (for year 2020): \$106.00
  
- B. New Owners License, Public Safety Investigation Fee, per applicant per year:
  - (for year 2016): \$84.00
  - (for year 2017): \$87.00
  - (for year 2018): \$90.00.
  - (for year 2019): \$93.00.
  - (for year 2020): \$96.00.
  
- C. Renewal of Owners License and Taxicab Inspection Fee, per Taxicab per Year:
  - (for year 2016): \$84.00.
  - (for year 2017): \$87.00
  - (for year 2018): \$90.00.
  - (for year 2019): \$93.00.
  - (for year 2020): \$96.00
  
- D. Transfer of Owners License:
  - (for year 2016): \$94.00.
  - (for year 2017): \$97.00

- E. New Operator's License:
  - (for year 2016): \$94.00.

Fingerprint Fees shall be an additional fee as determined by the Vineland Police Department.

BE IT FURTHER ORDAINED that should any portion of this Ordinance be deemed unenforceable by a court of competent jurisdiction, that portion so determined to be unenforceable, shall be void and the balance hereof shall remain in full force and effect.

BE IT FURTHER ORDAINED that any portion of Chapter 651 not amended hereby shall remain in full force and effect.

This Ordinance shall take effect upon adoption and publication according to law.
