WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing of Mobile Demineralizer System for West Sub C.T. for the Vineland Municipal Electric Utility – Generation Division, for a period of one year starting June 16, 2016, with option for a second year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on May 10, 2016, bids were received, duly opened and read aloud, being referred to the Assistant Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Assistant Business Administrator has, under date of June 6, 2016 submitted a written report and tabulation of the bids received and has recommended that an open-end contract for the furnishing of Mobile Demineralizer System for West Sub C.T. for the Vineland Municipal Electric Utility – Generation Division, be awarded to Simply Clean Air & Water Inc., Newington, CT, in the amount of \$15,600.00, said bid being the only bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-end contract for the furnishing of Mobile Demineralizer System for West Sub C.T. for the Vineland Municipal Electric Utility – Generation Division, for a period of one year starting June 16, 2016, with option for a second year, be and the same is awarded to Simply Clean Air & Water Inc., Newington, CT, in the amount of \$15,600.00, said bid being the only bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and


