I am pleased to offer your department the opportunity to participate in our annual Drive Sober or Get Pulled Over Statewide Labor Day Crackdown grant. The Division of Highway Traffic Safety is prepared to offer your department \$5,000 in overtime enforcement grant funding, to be utilized during the Drive Sober or Get Pulled Over 2016 Statewide Labor Day Crackdown from August 19 through September 5, 2016.

Drive Sober or Get Pulled Over grant applications must be submitted on-line through the SAGE e-grant system. Detailed instructions for submitting your grant on SAGE follow. Please note that the application for this grant will be available in SAGE beginning on June 15, 2016 and must be submitted electronically to NJDHTS by July 29, 2016.

If you do not plan to accept the grant, please advise me ASAP.

When you access the grant application in SAGE, please familiarize yourself with the Project Methodology, as you will be expected to adhere to all components of the grant. This is a reimbursement grant, meaning your agency will incur the costs and then submit documentation to the Division to be reimbursed. The maximum hourly rate that will be reimbursed for the enforcement overtime is \$50 per hour.

After you have submitted your completed application through SAGE, you will be notified of your approval through SAGE, as well. No written approvals will be sent out.
