A RESOLUTION AUTHORIZING THE WATER UTILITY SUPERINTENDENT TO EXECUTE THE NJDEP APPLICATION FOR WATER MAIN EXTENSION FOR FOREST GLEN MAJOR SUBDIVISION – ALMOND ROAD (BLOCK 402, LOTS 13, 14 & 16).

WHEREAS, as part of the standard application process for a Water Main Extension for Forest Glen Major Subdivision – Almond Road (Block 402, Lots 13, 14, and 16), to connect to the City of Vineland Water Utility System, the Water Utility Superintendent is required to execute a New Jersey Department of Environmental Protection application to construct, modify and operate public works facilities; and

WHEREAS, it is considered in the best interest of the City of Vineland to execute said application for a Water Main Extension Assessment for Forest Glen Major Subdivision – Almond Road (Block 402, Lots 13, 14, and 16);

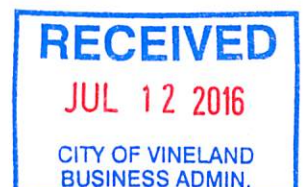

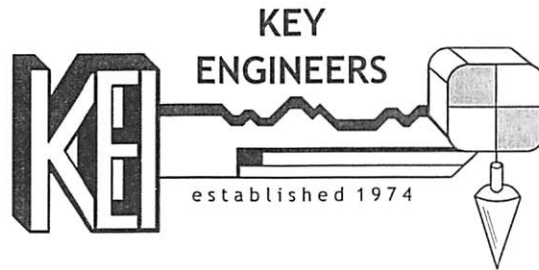

We are herewith submitting the following items in regard to the above referenced project for your review:

1. One (1) copy of the "BWSE Application" Form. We request that items 6 and 7 be endorsed in blue ink by the appropriate water utility representative.
2. One (1) copy of the New Jersey Department of Environmental Protection Technical Review Form BWSE-PA10 (09/13).
3. One (1) copy of BWSE-PA05E (09/13) Firm Capacity and Water Allocation Analysis. We request that the firm capacity information be provided by the water utility.
4. One (1) copy of the BWSE-PA10DET (09/13) "Checklist for Determination of Permit Requirements for Water Main Construction".
5. One (1) copy of the BWSE-PA05 (09/13) Checklist for Administrative Completeness.
6. One (1) set of the Construction Plans for the project.
7. One (1) copy of the "Technical Specifications".

We are providing this information to you in accordance with Form BWSE-PA10DET (09/13) "Checklist for the Determination of Permit Requirement for Water Main Construction". Since the project is fewer than 50 units, less than 3000 feet in length and does not require an interconnection with another water system, we are requesting approval via the simplified water main certification process. Also, Form BWSE-PA05E has been provided in blank form for you to complete the system source and water allocation analysis.

This application received approval from the NJDEP in November 2009 (NJDEP Permit # WCP 09009). However, due to the economy, the project was never constructed. Our recent communication with the Water Supply Element staff indicated that the application permit cannot be extended and must be resubmitted for review and approval. We respectfully request that you review the information, endorse the BWSE Application form, complete form BWSE-PA05E and return the package with original signatures so we can resubmit to the NJDEP and renew the permit.
