We are requesting an amendatory supplemental change order to Contract No. C13-0102, issued to Rodgers Group, LLC, Island Heights, NJ, for professional consulting services to Assist the Vineland Police Department in Securing New Jersey Association of Chiefs of Police (NJSACOP) Accreditation. This contract was authorized by Resolution No. 2013-494, adopted by City Council on September 24, 2013.

The change order requested in the amount of \$1,200.00 will provide for an extension of the contract period for four (4) month through January 24, 2017 to provide additional time required by VPD in order to comply with the accreditation program requirements, in the amount of \$300 per month. 
# **REQUEST FOR CHANGE ORDER FOR:**

## Rodgers Group Consulting Services in Securing NJSACOP Accreditation

This change order is necessary to comply with the original contract (signed 2013). The Fee Schedule (Section A, page 7, see attached) of the original contract states, "This proposal is designed to be executed in 12 months in exchange for the fee detailed above. In the event that additional time is required by the Vineland Police Department in order to comply with the accreditation program requirements, the Rodgers Group will bill the Township \$300 for each month after the conclusion of the 12 months that our assistance is necessary and requested to complete the program requirements."

<u>OPTION-</u> In the event that additional time is required by the Vineland Police Department in order to comply with the accreditation program requirements, the Rodgers Group will bill the Township \$300. for each month after the conclusion of the 12 months that our assistance is necessary and <u>requested</u> to complete the program requirements.
