A RESOLUTION TO AMEND AND SUPPLEMENT
RESOLUTION NO. 2014-434, AUTHORIZING
EXTRAORDINARY, UNSPECIFIABLE SERVICES
AGREEMENTS FOR HEALTH BENEFITS.

WHEREAS, the City Council of the City of Vineland, on October 14, 2014, adopted Resolution No. 2014-434, entitled “A RESOLUTION AUTHORIZING EXTRAORDINARY, UNSPECIFIABLE SERVICES AGREEMENTS FOR HEALTH BENEFIT COVERAGES FOR EMPLOYEES OF THE CITY OF VINELAND”; and

WHEREAS, there exists a need to amend and supplement said Extraordinary, Unspecifiable Service contract awarded to Allen Associates, Vineland, NJ for Health Benefit Coverages (Medical) for Employees of the City of Vineland, as authorized by Resolution No. 2014-434, by change order to Contract No. C15-0016, to provide for an additional month of coverage from January 1, 2017 to January 31, 2017, for Health Benefit Coverages (Medical), until the new Coverage period becomes effective under the State Health Benefits Program beginning February 1, 2017; and

WHEREAS, the City Comptroller has certified that funds for the amendment requested herein are available;

NOW, THEREFORE, BE IT RESOLVED by this City Council as follows:

1. THAT Resolution No. 2014-434, entitled “A RESOLUTION AUTHORIZING EXTRAORDINARY, UNSPECIFIABLE SERVICES AGREEMENTS FOR HEALTH BENEFIT COVERAGES FOR EMPLOYEES OF THE CITY OF VINELAND”; be and the same is hereby amended and supplemented to increase the amount of the contract by **an estimated amount of \$40,043.05** for an additional one month period from January 1, 2017 to January 31, 2017.

2. THAT the Purchasing Agent be and the same is hereby authorized to issue an amendatory supplemental change order #1 to Contract No. C15-0016 issued to Allen Associates, Vineland, NJ, **in an estimated amount of \$40,043.05**.

We are requesting an amendatory supplemental change order to Contract No. C15-0016, issued to Allen Associates, Vineland, NJ for Health Benefit Coverages (Medical) for Employees of the City of Vineland.
