RESOLUTION AUTHORIZING THE EXECUTION OF AMENDATORY SUPPLEMENTAL CHANGE ORDERS TO VARIOUS PROFESSIONAL SERVICES AGREEMENTS SO AS TO EXTEND THOSE SET TO EXPIRE ON OR BEFORE DECEMBER 31, 2016 TO JANUARY 31, 2017

WHEREAS, for purposes of bookkeeping and budgetary requirements, the City Council of the City of Vineland finds it to be in the best interest of the City to endeavor to have professional services agreements all expire on the same date; and
