- 2. THAT a contract for the furnishing of 2017 Landfill MW & Methane Testing be awarded to Eurofins QC, Inc., Southampton, PA, in the amount of \$13,947.00, said bidder being the second lowest bidder and considered in the best interest of the City of Vineland.
- 3. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City.

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
