

RESOLUTION NO. 2017 - 133

A RESOLUTION AUTHORIZING THE PURCHASE OF A MUSCO LIGHT-STRUCTURE GREEN SYSTEM FOR THE ROMANO YOUTH SPORTS COMPLEX – BASEBALL FIELD LIGHTING FROM MUSCO SPORTS LIGHTING LLC, 100 1ST AVENUE WEST, OSKALOOSA, IA 52577, IN THE AMOUNT NOT TO EXCEED \$178,777.00, PURSUANT TO A NATIONAL COOPERATIVE CONTRACT AGREEMENT WITH NATIONAL JOINT POWERS ALLIANCE (NJPA) CONTRACT 082114-MSL.

WHEREAS, the City of Vineland Municipal Electric Utility is in need of a Musco Light-Structure Green System for Romano Youth Sports Complex Baseball Field; and;

WHEREAS, the City of Vineland is a member of a National Cooperative Purchasing Agreement known as the National Joint Powers Alliance (NJPA) under member number 19409- and, NJPA is a national cooperative contract organization; and,

WHEREAS, NJPA, National Cooperative Purchasing Program has acted as lead agency and awarded Contract 082114-MSL, Facility & MRO, Athletic Field/Court and Parking Lot Lighting Systems. Specific information regarding the contract may be found on the NJPA website at: www.njpacoop.org and,

WHEREAS, N.J.S.A. 52:34-6.2 permits the City of Vineland to purchase the Musco Light-Structure Green System using the offered National Cooperative Contract without public bidding, subject to the submittal and acceptance of certain documentation by Musco Sports Lighting LLC;

WHEREAS, the City of Vineland intends under NJPA, under the Category: Facility & MRO, Sub-Category: Athletic Field/Court and Parking Lot Lighting Systems, Contract 082114-MSL, to purchase from Musco Sports Lighting LLC, 100 1st Avenue West, Oskaloosa, IA 52577, a Musco Light-Structure Green System for Romano Youth Sports Complex Baseball Field, in an amount not to exceed \$178,777.00, as listed in the Quotation, dated January 4, 2017, made available through the NJPA.

WHEREAS the Director of Electric Utility and the Qualified Purchasing Agent, with the concurrence of the Business Administrator, recommend the use of the National Cooperative Pricing through NJPA for this procurement;

WHEREAS, notice of the within purchase has been published on February 8, 2017, with a 10-day comment period as required by Local Finance Notice 2012-10 and;

WHEREAS, the City of Vineland Purchasing Agent has determined that the use of the offered National Cooperative Contract will result in cost savings after all factors, including charges for service, material and delivery have been considered and has verified that such equipment is not available through State Contract awarded by the Division of Purchase and Property in the New Jersey Department of the Treasury pursuant to N.J.S.A. 40A:11-12; and

CITY OF VINELAND, NJ

WHEREAS, the availability of funds for said purchase to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, that the Purchasing Agent is authorized to prepare a purchase order to procure the a Musco Light-Structure Green System for Romano Youth Sports Complex Baseball Field for a price not to exceed \$178,777.00

BE IT FURTHER RESOLVED that the purchase order shall contain a requirement that “the vendor shall maintain all documentation related to products, transactions or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request”.

Delivery to the job site from the time of order, submittal approval, and confirmation of order details including voltage and phase, pole locations is approximately 30-45 days. Due to the built-in custom light control per luminaire, pole locations need to be confirmed prior to production. Changes to pole locations after the product is sent to production could result in additional charges.

Notes

Quote is based on:

- Shipment of entire project together to one location
- Site voltage and phase to be confirmed prior to production
- Structural code and wind speed = 2015 IBC, 115 MPH, Importance Factor 1.0
- Standard soil conditions – rock, bottomless, wet or unsuitable soil may require additional engineering, special installation methods and additional cost
- Confirmation of pole locations prior to production

SUBJECT: Romano Youth Sports Complex – Baseball Field Lighting

Vineland started participating in the Green Acres Project in 1996 with our new field lighting provided by Musco sports lighting. We were very pleased with the ease of installation, the remote ballast features, and packaged pole units that allow the poles to be assembled and supplied as a unit. Since that time, we have managed at least fifteen (15) other Green Acres projects, all installing the Musco sports lighting package. Vineland Musco lighting now includes ten (10) baseball fields, nineteen (19) basketball, tennis, and hockey courts, and seven (7) soccer and football fields. We have had great success with the Musco installations, very little maintenance required, the light spill glare is minimal, and the light aiming stays true

Vineland is now looking to light a three-hundred and twenty (320) foot radius baseball field at our newest park, Romano Park. Musco has provided a quote for their newer LED package that provides greater energy savings, even lower spill glare, and a new, easier installation package. The quote through the National Joint Power Alliance (NJPA) is comparable to other sports lighting packages when considering the added materials provided, the higher quality, and the maintenance that is included.

The Musco package provides features and equipment that other manufacturers do not. They provide a control system complete with cellular link, individual fixture monitoring, and remote operational programming. The control system includes main control contactors for each pole location and lightning protection for the electronic equipment. This equipment is not provided by other manufacturers and would have to be procured and wired separately. The Musco LED package provides an up lit LED fixture on each pole so players can easily track fly balls, a feature that others do not include. The Musco system includes their assurance and warranty program that provides all materials, maintenance, and labor for twenty-five (25) years following installation.

Finally, in comparison to other manufacturers, the lighting is more consistent and uniform across the playing field, and the levels are guaranteed through the twenty-five (25) year warranty program. Considering the ease of installation, the lighting quality, the added features, and the provided maintenance, the NJPA pricing is comparable, and a savings when compared to publicly bid pricing.
