WHEREAS, the Assistant Business Administrator has, under date of April 18, 2017 submitted a written report and tabulation of the bids received and has recommended that a contract for Rental of Chiller for the Vineland Police Building, be awarded to Gaudelli Brothers, Inc., Millville, NJ, in the amount of \$44,500.00 for a five-month period, May 1, 2017 through September 30, 2017, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for Rental of Chiller for the Vineland Police Building, be and the same is awarded to Gaudelli Brothers, Inc., Millville, NJ, on their bid in the amount of \$44,500.00 for a five-month period, May 1, 2017 through September 30, 2017, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and
