WHEREAS this contract is awarded in an amount not to exceed \$186,608.78 for specified services, for a contract period of 210 days from notice to proceed; and

WHEREAS, the availability of funds for said Professional Services Contract to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the Local Public Contract Law (N.J.S.A. 40A:11-1, et seq) requires that the Resolution authorizing the award of contract for Professional Services without competitive bidding and the contract itself must be available for public inspection.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that said contract for Professional Services for Construction Inspection Services for Landis Avenue Resurfacing Phase 2 – Boulevard to West Avenue, be awarded to Remington & Vernick Engineers, Inc., Haddonfield, NJ, based upon the proposal received, pursuant to a fair and open process, in the amount not to exceed \$186,608.78 for a contract period of 210 days from notice to proceed.

# **Award Justification**

# CONSTRUCTION INSPECTION SERVICES FOR LANDIS AVENUE RESURFACING PHASE 2

Upon review of all seven (7) proposals, it was determined that Remington & Vernick Engineers (RVE) was the most qualified firm to complete the project. Technical review rating forms are attached for review.

After ranking the proposals based on technical proficiency, the highest ranked bidder's cost proposal was opened and a meeting was scheduled to discuss the scope of work and the cost proposal.

(Take note that, in this Federal process, the only cost proposal opened is that of the highest ranked proposer from a technical standpoint.)

On May 19, 2017, Brian Myers and David Maillet met with representatives of RVE. During that meeting, it was noted that the amount of time being devoted to Resident Engineer work appeared limited and should be moved up to truly reflect the amount of work needed in managing a Federally funded project. The consultant did admit that they cut the hours back from what they originally estimated.

On May 24, 2017, RVE emailed a revised cost proposal for the work of this project. It reflected the additional hours noted above and corrected an error found in the original proposal.

It is the opinion of the City Engineer that Remington & Vernick is very well qualified to perform the work of this project and that they have worked in good faith to provide the City of Vineland with a fair and reasonable price for the services to be rendered.


