Explanation for Cancelled Grant Resolution for June, 2017

*Be advised, the last City of Vineland Resolution to cancel old/unused grant balances was December, 2016

- 1. Boys & Girls Club Chaplaincy Program: New Police Administration decided not to continue with this program.
- 2. Police Dept Enforcement Grant(s) (DSGPO): Maximum reimbursable OT salary was \$50.00 per hour each Officer, so some Officers working detail may not reach the maximum. Also, there are certain circumstances when Officers do not sign up for detail.
- 3. Health Dept Grants YMCA; Perinatal (PREP): Salaries are fixed, however OE is estimated so invoices are sometimes less than anticipated.
- 4. NJ DOT Grants: Contractor bids less than allocated State funds initially approved.
- 5. UEZ 1st & 2nd Gen Grants; VDC Grant: Budgets were anticipated and not spent in full.
- 6. Vineland Downtown Improvement District PT Staff 2016: Position was only from May until December, 2016, individual didn't start until October.
