WHEREAS, has recommended by the Fire Chief, the Director of Information Services and the Purchasing Agent that a contract be awarded to Firehouse Software, Urbandale, Iowa, for the Purchase of the Firehouse Software Upgrade to 4 User Enterprise (SQL) System for the Vineland Fire Department, in an amount not to exceed \$20,335.00; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that:

This contract is awarded without competitive bidding in accordance with 40A:11-5(1)(dd) of the Local Public Contracts Law for the provision or performance of goods or services for the support or maintenance of proprietary computer hardware and software, except that this provision shall not be utilized to acquire or upgrade non-proprietary hardware or to acquire or update non-proprietary software.
2. The Purchasing Agent be and the same is hereby authorized to issue contract Firehouse Software, Urbandale, Iowa, for the Purchase of the Firehouse Software Upgrade to 4 User Enterprise (SQL) System for the Vineland Fire Department, in an amount not to exceed \$20,335.00.
3. Notice of this action shall be printed once in the Daily Journal.
