### MEMORANDUM TO BUSINESS ADMINISTRATION:

Request for Qualifications for Diversity Training were received and opened in my office on Friday, July 28<sup>th</sup> at 1:00 pm. Proposals were received from PRAC of Southern New Jersey and Major Ben's Consulting LLC. Both vendors provided all the mandatory documents. I reviewed both proposals and I offer the following:

- a. Both vendors have over 25 years of experience and with the information provided it appears that both can provide the services as requested.
- b. PRAC provided a cost of \$16,989.00 for training of ALL City Employees. Major Ben provided various costs depending on number of trainees. Using the estimated 700 employees their cost is \$51,190.90 which includes incidentals (hotel, mileage, etc.) in the amount of \$16,690.90.
- c. PRAC has an office on 275 N. Delsea Dr., Vineland and Major Ben's office is located in Collegeville, PA. which is reason for the incidental costs.

With the information provided above and all factors considered I would recommend award to PRAC as their cost proposal heavily outweighs that of Major Ben's.
