A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO SOUTH STATE MATERIALS, LLC, BRIDGETON, NJ FOR SUPPLYING AND DELIVERING VOC-COMPLIANT HIGH PERFORMANCE COLD PATCH THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Supplying and Delivering VOC-Compliant High Performance Cold Patch; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest, responsive, responsible bidder, South State Materials, LLC, Bridgeton, NJ, for the contract period September 1, 2017 through August 31, 2018 based on the quoted price as follows:

WHEREAS, the City of Vineland desires to enter into an agreement with South State Materials, LLC, for Supplying and Delivering VOC-Compliant High Performance Cold Patch under the cooperative pricing system contract awarded by the County of Cumberland for the contract period September 1, 2017 through August 31, 2018, in an amount based upon the quoted price, as stated above; and

WHEREAS, the City Comptroller has certified the availability of funds for the contract to be awarded herein;

THAT the Mayor and City Clerk are hereby authorized to execute an agreement with South State Materials, LLC, Bridgeton, NJ for Supplying and Delivering VOC- Compliant High Performance Cold Patch for the contract period September 1, 2017 through August 31, 2018, based upon the open-ended contract awarded by the County of Cumberland cooperative pricing system.
2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue a purchase order contract to South State Materials, LLC, Bridgeton, NJ, for Supplying and Delivering VOC- Compliant High Performance Cold Patch, as stated above.

RESOLUTION AWARDING CONTRACT FOR SUPPLYING AND DELIVERING VOC-COMPLIANT HIGH PERFORMANCE COLD PATCH FOR THE CUMBERLAND COUNTY PUBLIC WORKS DEPARTMENT AND THE CUMBERLAND COUNTY COOPERATIVE CONTRACT PURCHASING SYSTEM IDENTIFIER #181-CCCCPS (SOUTH STATE, INC.) (MAXIMUM AMOUNT OF \$147,700.00)

WHEREAS, this Board duly received and opened bids for supplying and delivering VOC-Compliant High Performance Cold Patch for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; and

WHEREAS, bids were received as follows:

* For bid evaluation purposes \$4.00/mile was added for total round-trip mileage for County pick-up of materials from the bidders plant location; Richard E. Pierson Materials (1.80 miles x \$4.00 = \$7.20 x 50 round-trips = \$360.00 round-trip for County pick-up at Bridgeton Plant) plus supply/deliver equals \$131,952.00, South State (3.40 miles x \$4.00 = \$13.60 x 50 round-trips = \$680.00 round-trip for County pick-up at Bridgeton Plant) plus supply/deliver equals \$123,080.00 total bid, and American Asphalt (66.40 miles x \$4.00 = \$256.60 x 50 round-trips = \$13,280.00 round-trip for County pick-up at Collingswood Plant) plus supply/deliver equals \$153,680.00 total bid.

WHEREAS, the Director of Purchasing has reported that South State, Inc., P.O. Box 68, 202 Reeves road, Bridgeton, NJ 08302 was the lowest responsive, responsible bidder; and

WHEREAS, the maximum contract award amount is \$122,400.00 and no amount will be

encumbered until such time as goods or services are ordered; and

WHEREAS, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to provide payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$122,400.00 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends an open-ended contract be awarded to South State, Inc. in accordance with the specifications and the bid of the contractor in the maximum amount of \$122,400.00 for the contract period September 1, 2017 through August 31, 2018.

2. That the proper officers of this Board are hereby authorized and directed to execute the open-ended contract hereby awarded.

3. That the said open-ended contract shall be charged a maximum of \$40,000.00 to the 2017 Budget and a maximum of \$82,400.00 shall be charged to the 2018 Budget.
