The Regular Meeting of the City Council of the City of Vineland was called to order by the President, Paul F. Spinelli.

President Spinelli led the Pledge of Allegiance.

The Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 28, 2016 by the City Clerk, in the following manner:

Harry Delgado of the New Jersey Association of Chiefs of Police noted that Vineland is the first Cumberland County police department to be accredited. He emphasized that it is a very difficult process the departments who earn it are in a very elite group. Accreditation brings joint insurance fund premium discounts. Vineland had a perfect on-site assessment, which is extremely rare. The accreditation is valid for three years. A framed certificate of accreditation was presented to Chief Beu.

Chief Beu thanked the mayor and City Council for their support, and also mentioned the work of Sgt. Chris Fulcher and officer David Vai for their work on the accreditation process. President Spinelli commented that on behalf of Mayor Fanucci, we are all proud of our police department.

Jess McConnell, of the Cumberland County Positive Youth Coalition, presented a plaque to Councilman Vargas for his work while a police officer mentoring the P.A.L. program. Councilman Vargas accepted, stating that his work at P.A.L. was from the heart. He thanked the organization for their recognition. President Spinelli said we are proud of the work Councilman Vargas did with P.A.L.
