The Municipal Clerk stated Public Notice of this meeting, pursuant to the Open Public Meetings Act, has been given on December 28, 2016 and April 25, 2017 by the City Clerk in the following manner:

- 2. Providing written notice to the offices of The Daily Journal and The Press of Atlantic City;

President Spinelli asked if anyone from the public would like to comment.

There was no public comment.

Representatives of the Gloucester, Salem, Cumberland Counties Municipal Joint Insurance Fund were present to review Vineland's membership. Paul Miola, Executive Director; Paul Forlenza, Deputy Executive Director; and Davd DeWeese, chief counsel for the JIF addressed City Council. A prepared packet was distributed and reviewed. It illustrated Vineland's pre-JIF program and the tri-county JIF program coverages and comparisons, focusing on the benefits of JIF membership. Cyber insurance coverage is a priority, which includes a hotline and vulnerability assessments. Council members thanked the JIF representatives for their presentation.

Councilwoman Calakos distributed packets of information from the VDID and asked that director Russell Swanson be invited to explain in more detail what is going on. President Spinelli directed Business Administrator Dickenson to invite Mr. Swanson for the May 16 work session.

Councilman Acosta gave a brief report from the Planning Board.

Councilman Franceschini offered an update on Health Department matters.

President Spinelli asked Utilities Director John Lillie if elevated water tanks are still being maintained. Director Lillie assured Council that there is a schedule and work is proceeding to maintain the interior and exterior of tanks.

Councilman Acosta raised the issue of runoff elections. Solicitor Tonetta will check into the statutes to find out if that provision can be addressed, in light of the 10-year restriction after the municipal elections were moved from May to November.
