WHEREAS, the City of Vineland intends to enter into a contract with a State Contract Vendor through this resolution and properly executed contracts, which shall be subject to all the conditions applicable to the current State contracts, for the purchase of Two (2) 2018 Police Interceptor Utility, All Wheel Drive Vehicles at a cost of \$26,877.00 each, for a total amount of \$53,754.00; and

WHEREAS, it has been recommended that a contract be awarded to Winner Ford, Cherry Hill, NJ (A88728) based upon the proposal received, for a total amount of \$53,754.00; and
