The Corporation agrees to provide funding through a grant award in the amount of \$757,598.00 to the City to cover a portion of the salaries and wages and other expenses of the Economic Development Division for the period January 1, 2018 through December 31, 2018, as shown on Exhibit "A" attached hereto.
- 2. Upon the expiration of this agreement, the City shall transfer to the Corporation any funds on hand at the time of expiration and any accounts receivable attributable to the use of the funds granted hereunder.
