for a total amount of \$34,100.00, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the Demolition of All Structures located at 204 South Seventh Street and 757 South East Avenue, be and the same is awarded to International Waste Services, LLC, Philadelphia, PA, on their bid in the amount as stated above, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and


