#### A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO W.B. MASON COMPANY, EGG HARBOR TOWNSHIP, NJ FOR DELIVERING AND SUPPLYING OFFICE SUPPLIES THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Delivering and Supplying Office Supplies; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest responsive, responsible bidder, W.B. Mason Company, Egg Harbor Township, NJ, for the period April 1, 2018 through December 31, 2019, with option to renew for one (1) additional two (2) year period commencing January 1, 2020 through December 31, 2021, based on unit pricing for Section A, Core Items and a 69.5% discount for Section B, Included Items for numerous other items from the United Stationers Catalog. For Section A, (Core Items) the contractor may request unit price adjustments for the period January 1, 2019 to December 31, 2019 which shall not exceed the Index Rate posted on the NJ Department of Local Government Services. If no request received by November 30, 2018 the prices included in the original agreement shall prevail for the January 1, 2019 to December 31, 2019 contract period. For Section B (Included Items) the 69.5% discount shall be fixed for the entire term of the contract; and

WHEREAS, the City of Vineland desires to enter into an agreement with W.B. Mason Company, for Delivering and Supplying Office Supplies under the cooperative pricing system contract awarded by the County of Cumberland for the period April 1, 2018 through December 31, 2019, with option to renew for one (1) additional two (2) year period commencing January 1, 2020 through December 31, 2021, and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the contract to be awarded herein;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, as follows:

1. THAT the Mayor and City Clerk are hereby authorized to execute an agreement with W.B. Mason Company, for Delivering and Supplying Office Supplies for the period April 1, 2018 through December 31, 2019, with option to renew for one (1) additional two (2) year period commencing January 1, 2020 through December 31, 2021, based on unit pricing for Section A, Core Items and a 69.5% discount for Section B, Included Items for numerous other items from the United Stationers Catalog. For Section A, (Core Items) the contractor may request unit price adjustments for the period January 1, 2019 to December 31, 2019 which shall not exceed the Index Rate posted on the NJ Department of Local Government Services. If no request received by November 30, 2018 the prices included in the original agreement shall prevail for the January 1, 2019 to December 31, 2019 contract period. For Section B (Included Items) the 69.5% discount shall be fixed for the entire term of the contract.

2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue a purchase order contract to W.B. Mason Company, for Delivering and Supplying Office Supplies, as stated above.

On March 8, 2018 the County of Cumberland solicited bids for Supplying and Delivering Office Supplies for themselves and for the Cumberland County Cooperative Contract Purchasing System, of which we are a member of.

The Cumberland County Board of Chosen Freeholders adopted a Resolution to award an open-ended contract to W.B. Mason Company, to provide these services to the County. W.B. Mason has elected to extend their prices to government entities within the geographic boundaries of the County.

The contract period is April 1, 2018 – December 31, 2019 with an option to renew for one additional two (2) year period commencing January 1, 2020 through December 31, 2021.

We recently had a contract with W.B. Mason through the County which expired on March 31, 2018. The new contract with W.B. Mason has unit pricing for Section A, Core Items and a 69.5% discount for Section B, Included Items for numerous other items from the United Stationers Catalog. For Section A (Core Items) the contractor may request unit price adjustments for the period January 1, 2019 to December 31, 2019 which shall not exceed the Index Rate posted on the NJ Dept. of Local Government Services. If no request received by November 30, 2018 the prices included in the original agreement shall prevail for the January 1, 2019 to December 31, 2019 contract period. For Section B (Included Items) the 69.5% discount shall be fixed for the entire term of the contract.
