A RESOLUTION AUTHORIZING THE EXCLUSION OF THE PUBLIC FROM A MEETING BETWEEN THE MAYOR, CITY COUNCIL, CITY CLERK AND STAFF, BUSINESS ADMINISTRATOR AND STAFF, SPECIAL COUNSEL DECOTIIS, FITZPATRICK AND COLE LLP AND STAFF, DIRECTOR OF THE MUNICIPAL UTILITIES AND STAFF, CITY SOLICITOR AND STAFF CONCERNING MATTERS REGARDING PENDING LITIGATION OR ANTICIPATED LITIGATION IN WHICH THE PUBLIC BODY IS OR MAY BECOME A PARTY AND AUTHORIZING THE DISCLOSURE OF MINUTES OF SAID MEETING AS PROVIDED HEREIN.

WHEREAS, N.J.S.A. 10:4-12, Open Public Meetings Act, permits the exclusion of the public from the meeting of a public body where the subject matter of that meeting involves pending or anticipated litigation in which the public body is or may become a party; and

WHEREAS, the Council of the City of Vineland desires to meet with the Mayor, City Clerk And Staff, Business Administrator and Staff, Special Counsel DeCotiis, Fitzpatrick and Cole LLP and Staff, Director of the Municipal Utilities and Staff, City Solicitor and Staff concerning the matter of C&H Industrial Services, Inc. vs. City of Vineland, et al. vs Berkley Insurance Group et al.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Vineland that:

1. The public shall be excluded from a meeting of the Council of the City of Vineland on July 24, 2018 in the Caucus Room, City Hall, Vineland, New Jersey, immediately following the regular work session of City Council.
2. The general nature of the subject matters of the closed meeting shall pertain to pending or anticipated litigation in which the public body is or may become a party regarding the matter set forth herein above.
3. Disclosure of the minutes of the closed meeting authorized above between the Council of the City of Vineland, the Mayor, City Clerk And Staff, Business Administrator and Staff, Special Counsel DeCotiis, Fitzpatrick and Cole and Staff, Director of the Municipal Utilities and Staff, City Solicitor and Staff shall be made following a final decision and determination of said matter excepting information which must remain private.
4. It is anticipated that the minutes of the deliberation conducted in closed session may be disclosed to the public within one hundred eighty (180) days, however, any personal confidential information may not be released.
