RESOLUTION ACCEPTING THE PROPOSAL FOR A CONTRIBUTION IN LIEU OF TAXES DATED JULY 30, 2017 FROM ELWYN, NEW JERSEY FOR PROPERTIES USED IN FURTHERANCE OF THEIR CHARITABLE PURPOSE.

WHEREAS, Elwyn New Jersey (Elwyn) operates several facilities (Properties) in the City of Vineland providing needed resources for challenged children and adults including behavioral health, early childhood, education health services support for living, employment and adult daycare; and

WHEREAS, Elwyn has filed for all of the necessary exemption applications to establish a full tax exemption for said Properties as they are a recognized charitable organization, however it is the policy of Elwyn to voluntarily make a contribution in lieu of tax payment for each tax year, subject to the adequacy of funding to assist the host community in the cost for municipal services; and

WHEREAS, Elwyn has requested the City of Vineland accept the following contributions in lieu of taxes based upon the assessed valuation and the tax rate in place at the time the Properties were purchased for the year 2018 and thereafter, subject to funding:
