

Recommendation: Charles Marandino is the apparent low, responsive, responsible bidder. Their bid exceeded the Engineer's Estimate of \$186,750.64 by \$2,507.56. If Department is able to secure the additional funding of \$2,507.56 I have no issue if Department recommends award to Charles Marandino. If additional funding is not available, the only two (2) options are to reject all bids as the lowest bid exceeded the estimate and authorize to re-bid to substantially change the specifications or reject and authorize to negotiate as authorized by 40A:11-5(3) where the Governing Body has rejected all bids on two (2) separate occasions on the basis of cost exceeding the estimate.
