A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO SOUTH STATE MATERIALS LLC, BRIDGETON, NJ FOR SUPPLYING AND LAYING HOT MIX ASPHALT THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM, IDENTIFIER #181-CCCCPS BID #18-28.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Supplying and Laying Hot Mix Asphalt; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest responsive, responsible bidder, South State Material LLC, Bridgeton, NJ, for the contract period September 1, 2018 through August 31, 2019, based on the quoted price as follows:

WHEREAS, the City of Vineland desires to enter into an agreement with South State, Inc., for Supplying and Laying Hot Mix Asphalt under the cooperative pricing system contract awarded by the County of Cumberland for the contract period September 1, 2018 through August 31, 2019, in an amount based upon the quoted price, as stated above; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the contract to be awarded herein;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, as follows:

2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue a purchase order contract to South State, Material LLC, Bridgeton, NJ for Supplying and Laying Hot Mix Asphalt, as stated above.

WHEREAS, this Board duly received and opened bids for supplying and laying hot mix asphalt for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; and

WHEREAS, the maximum contract award amount is \$150,100.00; and

WHEREAS, no amount will be encumbered until such time as good or services are ordered; and

WHEREAS, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to provide payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as

determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$150,100.00 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends a contract be awarded to South State, Inc. in accordance with the specifications and the bid of the contractor in the maximum amount of \$150,100.00 for the contract period September 1, 2018 through August 31, 2019.

2. That, additionally, South State, Inc. shall be declared the winning bidder for the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS.

3. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.
