RESOLUTION AUTHORIZING A CONTRACT AWARD TO A STATE CONTRACT VENDOR, WINNER FORD, CHERRY HILL, NEW JERSEY, FOR THE PURCHASE OF THREE (3) 2020 FORD EXPLORERS (TWO FOR LICENSES AND INSPECTIONS AND ONE FOR UCC), IN AN AMOUNT NOT TO EXCEED \$96,192.00.

WHEREAS, it has been recommended that a contract be awarded to Winner Ford, Cherry Hill, New Jersey (A88728) for the purchase of three (3) 2020 Ford Explorers (two for Licenses & Inspections and one for UCC), in an amount not to exceed \$32,064.00 each, for a total cost of \$96,192.00, in accordance with the quote from Winner Ford, Cherry Hill, New Jersey, attached hereto and made a part hereof; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for said contract to be awarded; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts.
