WHEREAS, the City of Vineland desires to comply with said requirements of N.J.A.C. 5:30-11.1, et seq., and to that end herewith files with the governing body a report stating the facts involved and indicating that the proposed change order may be allowed under these regulations; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the amendatory supplemental change order for which authorization is requested in the amount of \$15,570.00; now, therefore,

Amendatory Supplemental Change Order No. 1 Contract No. C18-0035 Berenato Contractors, Inc., Hammonton, NJ to Complete the Landis Avenue Signal Project, Phase 2 (Boulevard to West Avenue)

We are requesting that an amendatory supplemental change order be issued to Contract No. C18-0035, issued to Berenato Contractors, Inc., Hammonton, NJ to Complete the Landis Avenue Signal Project, Phase 2 (Boulevard to West Avenue). This contract was authorized by Resolution No. 2018-88, adopted by City Council on February 27, 2018.

The change order requested, in the amount of \$15,570.00, is necessary due to an error made on the quantity of the 8 Phase Controllers with Battery Backup.
