A RESOLUTION TO AMEND RESOLUTION NO. 2019-87 ENTITLED A RESOLUTION AUTHORIZING THE CANCELLATION OF TAXES FOR **CY 2019** FOR THE REASON RECOMMENDED BY THE CITY OF VINELAND TAX COLLECTOR.
